

## **“Fall 2023 Adopt-A-Teacher Program”**

**NO PURCHASE NECESSARY TO ENTER OR TO WIN.**

**ELIGIBILITY:** The Promotion is open to teachers who are legal residents of the United States who are eighteen (18) years of age or older at the time of entry who live, work, or worship in the counties of Cochise, Coconino, Gila, La Paz, Mohave, Maricopa, Navajo, Pima, Pinal, Yavapai or Yuma.
