

## Welcome Home Sweepstakes (“Promotion”) Official Rules

### NO PURCHASE NECESSARY TO ENTER OR TO WIN. VOID WHERE PROHIBITED.

**ELIGIBILITY:** The Promotion is open only to legal residents of the State of Arizona who are 18 years of age or older at the time of entry. Employees, officers, and directors, including immediate family members (spouse, parent, child, sibling and their respective spouses, regardless of where they reside) and members of the same household (whether or not related) of Desert Financial Federal Credit Union (“Sponsor”), and its respective parents, affiliated companies, subsidiaries, advertising and promotion agencies, and any and all other companies associated with the Promotion are not eligible to participate or win the Prize (defined below). By successfully submitting an entry form during the Entry Period, you will receive one entry in the Promotion.

Entrants must fully complete and submit all nonoptional data requested on the online entry form to be eligible. Incomplete and/or inaccurate entries are void. All entries must include a valid email address for the entrant. Entrants to the Promotion may be given the option to receive (a) telephone calls from Sponsor regarding home mortgage loans; (b) commercial emails from Sponsor and/or (c) mobile text messages and updates from Sponsor. **NOTIFICATION:** The potential winners will be notified at the email address, postal address, telephone number, email address, and/or social media account (in the sole discretion of Sponsor) provided at the time of entry (the “Preliminary Prize Notification”). In the event that any potential winner does not respond to any such Preliminary Prize Notification within 48 hours of the date of issuance of the Preliminary Prize Notification or declines the Prize for any reason, the entry will be disqualified, the Prize will be forfeited and, at Sponsor’s sole discretion and time permitting, an alternate potential winner may be randomly selected from among all remaining eligible entries.
