

**Desert Financial's 3 Ways to Win Debit Sweepstakes ("Sweepstakes")
Official Rules**

NO PURCHASE NECESSARY TO ENTER OR TO WIN. VOID WHERE PROHIBITED.

ELIGIBILITY: The Promotion is open only to members of Desert Financial Credit Union who are 18 years of age or older at the time of entry. Employees, officers, and directors of Desert Financial Credit Union ("Sponsor"), and its respective parents, affiliated companies, subsidiaries, advertising and promotion agencies, and any and all other companies associated with the Promotion, as well as their immediate family members (spouse, parent, child, sibling and their respective spouses, regardless of where they reside) and members of the same household (whether or not related) are not eligible to participate or win the Prize (defined below). The Promotion is subject to all applicable federal, state, territory, and local laws, rules and regulations. Void where prohibited or restricted by law, rule or regulation.

HOW TO ENTER: The Promotion begins at 12:01AM Arizona time on September 3, 2020, and ends at 11:59PM Arizona time on September 30, 2020 ("First Entry Period"); 12:01AM Arizona time on October 1, 2020, and ends at 11:59PM Arizona time on October 31, 2020 ("Second Entry Period"); 12:01AM Arizona time on November 1, 2020, and ends at 11:59PM Arizona time on November 30, 2020 ("Third Entry Period"); 12:01AM Arizona time on December 1, 2020, and ends at 11:59PM Arizona time on December 31, 2020 ("Fourth Entry Period"). All eligible Desert Financial Credit Union members as of the beginning of the Entry Period who have used a Desert Financial Credit Union debit card for at least one (1) transaction that posts to their Desert Financial checking account during the eligible period at the time of the drawing automatically receive one entry in the Promotion for that Entry Period. Automatic Entries will not be awarded for accounts not in good standing at the time of drawings (in Sponsor's sole discretion), ATM transactions, cash advances, balance transfers, account adjustment transactions/returns, unauthorized usage (including use made with lost, stolen or fraudulent cards), and fees assessed on the Account. Eligible individuals may also enter the promotion by mailing a self-addressed and postage paid postcard to Desert Financial Credit Union Attn: Marketing Department, 148 N. 48th Street, Phoenix, AZ 85034 (a "Mail-In Entry"). Each Mail-In Entry must be received prior to the expiration of the Entry Period to which it applies. Limit one Mail-In Entry per person per Entry Period. All Mail-In Entries must: (i) state "Entry for Desert Financial's 3 Ways to Pay Debit Sweepstakes"; (ii) include the entrant's name, mailing address, phone number, and e-mail address; (iii) state the Entry Period (i.e. "First Entry Period"); and (iv) be received by Sponsor prior to the end of the applicable Entry Period. Late, incomplete, and/or inaccurate entries are void. All information submitted by entrants is subject to and will be treated in a manner consistent with the Desert Financial's Terms of Use available at <https://www.desertfinancial.com/legal> and Privacy Policy accessible at <https://www.desertfinancial.com/privacy-policy>. Entrants to the Promotion may be given the option to receive (a) telephone calls from Sponsor regarding home equity loans or lines of credit; (b) commercial e-mails from Sponsor and/or (c) mobile text messages and updates from Sponsor. Eligibility to participate in the Promotion is not dependent upon entrant's consent to receive such calls, e-mails, and/or mobile text messages and updates, and consenting to receive such calls, e-mails, and/or mobile text messages and updates will not impact any entrant's chances of winning. Standard messaging rates apply to mobile text messages and updates. Check with your mobile service provider for more information.

RANDOM DRAWING: The potential winner(s) of the Promotion will be selected by random drawing on or about: (a) October 14, 2020, for the First Entry Period; (b) November 11, 2020, for the Second Entry Period; (c) December 9, 2020, for the Third Entry Period; and (d) January 13, 2021, for the Fourth Entry Period. Potential winners will be selected from among all eligible entries received. Subject to verification of eligibility and compliance with the terms of these Official Rules, the potential winner(s) will be declared the official winner(s) of the Promotion (each a "Winner"). The decisions of Sponsor are final and binding on all matters relating to this Promotion. Odds of winning depend on the total number of eligible entries received.

NOTIFICATION: The potential winner(s) will be notified at the e-mail address, postal address or telephone number (in the sole discretion of Sponsor) provided at the time of entry (the "Prize Notification"). In the event that any potential winner does not respond to any such Prize Notification within 48 hours of the date of issuance

of the Prize Notification or declines the Prize for any reason, the entry will be disqualified, the Prize will be forfeited and, at Sponsor's sole discretion and time permitting, an alternate potential winner may be randomly selected from among all remaining eligible entries. The potential winner(s) may be required to submit his/her valid social security number and/or other identification to Sponsor, may be required to execute, have notarized and return an Affidavit of Eligibility and Release of Liability and, unless prohibited by law, Publicity, within five days of the date of the Prize Notification. Entries generated by a script, macro or other mechanical or automated means will be disqualified.
