

Thanks (Half) a Million Sweepstakes

Official Rules

NO PURCHASE NECESSARY TO ENTER OR TO WIN. VOID WHERE PROHIBITED.

ELIGIBILITY: The Thanks (Half) a Million Sweepstakes (the "Promotion") is open only to (a) members of Desert Financial Credit Union in good standing (according to Sponsor's reasonable discretion and general business practices) or (b) legal residents of the State of Arizona who are 18 years of age or older at the time of entry. Employees, officers, and directors of Sponsor, and its parents, affiliated companies, subsidiaries, advertising and Promotion agencies, and any and all other companies associated with the Promotion, as well as their immediate family members (spouse, parent, child, sibling and their respective spouses, regardless of where they reside) and members of the same household (whether or not related) are not eligible to participate or win the Prize (defined below). If a mail-in entry is drawn and the judges are unable to determine the entrant's information due to illegible writing, that entry will be disqualified. No copies, mechanical reproductions, or metered mail will be accepted. Mail-in entries must be postmarked by the last day of the Entry Period and received no later than seven (7) calendar days after the last day of the Entry Period. Proof of mailing does not constitute proof of delivery. The Sponsor is not responsible for lost, late, stolen, incomplete, inaccurate, undelivered, delayed, misdirected, damaged, postage-due, or illegible entries. Once submitted, entries become the sole property of the Sponsor and will not be acknowledged or returned.

ODDS: Odds of winning depend on the total number of eligible entries received during the Entry Period.

WINNER SELECTION & NOTIFICATION: The potential winner(s) of the Promotion will be selected by random drawing on or about January 31, 2026, from among all eligible entries received. Subject to verification of eligibility and compliance with the terms of these Official Rules, the potential winner(s) will be declared the official winner(s) of the Promotion (each a "Winner"). The decisions of Sponsor are final. The potential winner(s) will be notified at the e-mail address, postal address, or telephone number (in the sole discretion of Sponsor) provided at the time of entry (the "Prize Notification"). In the event that any potential winner does not respond to any such Prize Notification within twenty-four (24) hours of the date of issuance of the Prize Notification or declines the Prize for any reason, the entry will be disqualified, the Prize will be forfeited and, at Sponsor's sole discretion and time permitting, an alternate potential winner may be randomly selected from among all remaining eligible entries. The potential winner(s) may be required to submit valid identification to Sponsor (including but not limited to a valid Social Security number for tax reporting purposes), and may be required to execute, have notarized and return an affidavit of eligibility and release of liability and, unless prohibited by law, publicity, within five (5) days of the date of the Prize Notification.
