

## Double Your Paycheck Sweepstakes

### Official Rules

**NO PURCHASE NECESSARY TO ENTER OR TO WIN. VOID WHERE PROHIBITED.**

**ELIGIBILITY:** The Sweepstakes is open only to members of Desert Financial Credit Union who are 18 years of age or older at the time of entry. Employees, officers, and directors of Sponsor, and its parents, affiliated companies, subsidiaries, advertising and Sweepstakes agencies, and any and all other companies associated with the Sweepstakes, as well as their immediate family members (spouse, parent, child, sibling and their respective spouses, regardless of where they reside) and members of the same household (whether or not related) are not eligible to participate or win the Prize (defined below). The Sweepstakes is subject to all applicable federal, state, territory, and local laws, rules and regulations. Void where prohibited or restricted by law, rule or regulation.

**HOW TO ENTER:** The Sweepstakes begins on September 15, 2025, and ends on March 31, 2026 ("Entry Period"). To be eligible, participants must set up a new (*i.e.*, no direct deposit received in the six (6) months preceding the Entry Period) qualifying direct deposit and meet all additional entry requirements by the end of the Entry Period. For purposes of entry, only the primary account owner will be counted, regardless of who initiates or sets up the qualifying direct deposit. Limit one entry per primary account owner. Incomplete and/or inaccurate entries are void. Eligibility to participate in the Sweepstakes is not dependent upon entrant's consent to receive calls, emails, and/or mobile text messages and updates, nor will such consent impact any entrant's chances of winning. There are two (2) ways to enter:

**Automatic Entry via New Qualifying Direct Deposit:** An entrant will receive one (1) entry into the Sweepstakes by setting up a new recurring qualifying direct deposit of at least \$500 aggregate per month into a Desert Financial Credit Union checking or savings account that consecutively deposits at least two (2) times during the Entry Period. General ACH payments such as Zelle, Venmo, or other nonrecurring ACH transfers do not qualify as recurring direct deposits for purposes of Sweepstakes eligibility.

**Mail-In Entry:** An eligible entrant may enter this Sweepstakes without making a direct deposit. To enter by mail, legibly print your full name, address (including zip code), telephone number (including area code), and email address (optional) on a 3" x 5" card and mail it to: Desert Financial Credit Union, Attn: Marketing – Direct Deposit Sweepstakes, 148 N. 48<sup>th</sup> Street, Phoenix, Arizona 85034. If a write-in entry form or card is drawn but the judges are unable to determine the winner due to illegible writing, that entry will be disqualified. No copies, mechanical reproductions, or metered mail will be accepted. Mail-in entries must be postmarked by the last day of the Entry Period and received no later than seven (7) calendar days after the last day of the Entry Period. Proof of mailing does not constitute proof of delivery. The Sponsor is not responsible for lost, late, stolen, incomplete, inaccurate, undelivered, delayed, misdirected, damaged, postage-due, or illegible entries. Once submitted, entries become the sole property of the Sponsor and will not be acknowledged or returned.

**ODDS:** Odds of winning depend on the total number of eligible entries received during the Entry Period.

**WINNER SELECTION & NOTIFICATION:** The potential winner(s) of the Sweepstakes will be selected by random drawing on or about April 8, 2026, from among all eligible entries received. Subject to verification of eligibility and compliance with the terms of these Official Rules, the potential winner(s) will be declared the official winner(s) of the Sweepstakes (each a "Winner"). The decisions of Sponsor are final. The potential winner(s) will be notified at the e-mail address, postal address, or telephone number (in the sole discretion of Sponsor) provided at the time of entry (the "Prize Notification"). In the event that any potential winner does not respond to any such Prize Notification within twenty-four (24) hours of the date of issuance of the Prize Notification or declines the Prize for any reason, the entry will be disqualified, the Prize will be forfeited and, at Sponsor's sole discretion and time permitting, an alternate potential winner may be randomly selected from among all remaining eligible entries. The potential winner(s) may be required to submit valid identification to Sponsor (including but not limited to a valid Social Security number for tax reporting purposes), and may be required to execute, have notarized and return an affidavit of eligibility and release of liability and, unless prohibited by law, publicity, within five (5) days of the date of the Prize Notification. Failure to deliver the foregoing may result in disqualification and Prize forfeiture.

**PRIZE(S):** The total approximate retail value of the Sweepstakes prizes is up to \$5,000.00 each. Five (5) Winners will be awarded an amount equal to their last qualifying direct deposit, up to \$5,000.00, paid by check. General ACH payments such as Zelle, Venmo, or other nonrecurring ACH transfers do not qualify as recurring qualifying direct deposits for purposes Prize determination. If the winning entry is a Mail-In Entry, the prize will be a fixed cash amount of \$1,000 paid by check. Each of the foregoing is referred to as a "Prize" as applicable. All Prize details shall be determined in the sole and absolute discretion of Sponsor. Winner is fully responsible for any and all applicable

federal, state, territory, and local taxes (including income and withholding taxes). All costs and expenses associated with Prize acceptance and use are the sole responsibility of Winner. Sponsor reserves the right to substitute the Prize (or any portion thereof) with a prize of comparable or greater value at its sole and absolute discretion. Prizes may not be resold. Entrants agree to defend and indemnify Released Parties from and against any claim, damage, judgment, or any other loss arising out of Entrants' participation in the Drawing, including but not limited to any suit, claim, or damage arising out of Entrant driving to any location in connection with the Drawing.
